> Faculty :

- ❖ Sr. level faculty in cadre ratio as per AICTE norms should be appointed.
- ❖ AICTE Pay scales should be implemented to all the faculty and staff.
- ❖ Faculty in the Humanities & Sc. should be appointed in the ratio of 1:15 for the incoming batch of students.

> Built up area :

- ❖ There is a shortfall of 2957sq. mt. in the built up area as only 10030 sq. mt. is available against a requirement of 12987 sq.mt. (deficiency 23 %).

> Others :

- ❖ Placement cell needs improvement.
- ❖ The deficiencies communicated in the last approval letter are not fully complied with.
