
NOTICE

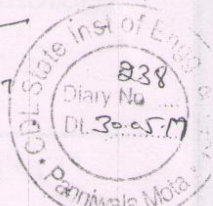

NOTIFICATION

The Vice-Chancellor, after considering recommendations of the committee under the chairmanship of the Registrar of its meeting held on 29/05/2017 regarding exemption of the fine penalty already conveyed vide Endost. No. Regn/R-II/17/1085-1104 dated 05.05.2017 to be paid by the colleges who have not submitted the requisite documents of the admitted students required for finalization of registration in the university, has approved following amendments:

In view of the requests of students and the Director/Principal of affiliated colleges, the fine of Rs. 20.00 per day per student upto a maximum penalty of Rs.500-Lac per college per session may be calculated w.e.f. 01.01.2017. The fine should be deposited with the Director/Principal of college concerned in one lot for a session with the requisite documents. However, late fee for submission of registration certificate by the students will remain same.

The Principal/Director of the affiliated colleges are given last opportunity to submit the pending documents of the admitted students alongwith requisite fine for finalization of registration in the university by deputing their officials as per following schedule
