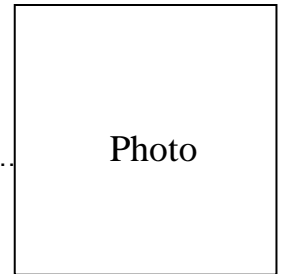

**Terms & Conditions (For Girls Hostel Mess)**

1. Tender will be for the period from July 2017 to June 2018. The successful tenderer shall have to deposit security on spot. The security for Girls Hostel Mess is Rs. 50000/- (Rs. Fifty Thousand only). The mess will be allotted on the basis of lowest rates for the diet as per the menu supplied. Although the Director-Principal will be final authority to allot the tender. The security will be refunded at the end of the period of tender without interest.
2. The building of mess entrusted to the licensee will be utilized for the purpose it has been allotted and would be kept in perfect sanitary conditions. The premises shall be handed over back to the Institute after the termination of the license period in the same condition with all the fittings and fixtures as provided by the Institute. The period of the tender may be increased further by the Director-Principal on the satisfactory services.
3. Institute will not provide cooking gas and cooking utensils.
4. The licensee shall display the rates for various items/services at prominent places.
5. The rates for items/articles to be served or sold shall in no case be higher than the rates as approved by the Institute from time to time. In case he is found charging higher rates than those approved by the Institute, the license of the Mess shall be cancelled.
6. The quality of food/items to be served or sold should be good. The licensee shall also provide at the Mess/canteen a complaint and suggestion box which will be open for inspection by the representative of the Institute.
7. Electricity bill will be paid by the licensee on actual basis every month by 10<sup>th</sup> of following month. The licensee shall have to install his own electric meter. In case the amount is not deposited by due date then penal interest @ 18% per annum will be imposed and after one month the connection will be disconnected.
8. Institute reserves the right to exercise check in any form at any time.
9. In case of complaint, deterioration of quality of food or otherwise if observed, the licensee shall be liable to pay reasonable penalty imposed by the Institute and shall deposit the penalty amount within a week from the date of issue of such orders.
10. In case of any loss or damage to the inmates due to licensee or his employees' negligence, the licensee shall be responsible to make good the compensation payable to the inmates for loss/damage.
11. The licensee shall not transfer or sublet the Mess.
12. The licensee shall not make any addition/alterations in the Institute premises without written approval of the Institute. He will make good the damage caused to the Institute's property by him or his employee(s) at any point.
13. The licensee shall not make any addition/alterations in the mess menu. Although the Mess menu may be changed /altered by the authorities in the interest of inmates.
14. Institute reserves the right to cancel the license after giving one month notice for infringement of agreement/terms & conditions or in the interest of Institute. In case

the Mess is not vacated within one month after receiving the notice, Institute shall have the right to impose penalty as deemed fit in addition to take other action under the rules.

15. The licensee shall not stock any empty packaging cases, baskets or any other material on the roof of the premises or in the open space outside the premises allotted to him.
16. The licensee shall be fully responsible for good conduct and character of his employee(s) and shall also keep the servants in neat and clean clothes preferably in proper clean and washed uniform. His employees are not allowed to visit residential area of inmates.
17. In case the licensee wants to vacate the Mess, he will have to give one month's notice.
18. No General Power of Attorney will be acceptable.
19. The licensee shall have to disclose the identity with photographs to the Institute at the time of submission of agreement deed.
20. In case of any dispute not covered in the terms & conditions and agreement, the matter will be referred to the Director-Principal whose decision will be final in all matters.
21. The licensee shall provide the photo & ID of his workers to the concerned Officers of Institute.
22. The licensee will deposit the sample of flour (Shakti bhog/damroo/bheem/ or similar brand) and rice (cella rice or similar brand) in sealed packet every month to be served by him. Ghee to be used will be of brand Gagan/Sohna/Ginni/Fortune/Saffola or similar brand. Spices to be used will be of the brand M.D.H./Patanjali/Rajesh/Ramdev or similar brands.
23. The licensee may charge minimum for 22 days diets from the inmates during a period of one month. If hostel remains closed for more than 10 days due to vacations or what so ever be reason then the diet will charged as per actual.
24. The licensee shall follow the Mess timings as provided by the warden and will not make any addition/alterations in the timings.
25. It will be responsibility of the licensee to collect the diet charges from the inmates. If any inmate(s) does not submit the mess bill by 10<sup>th</sup> of the following month then in such case the name of the inmates may be given to concerned warden for further action.
26. No student will be served food in his room.
27. Mess of Boys Hostel/Girls Hostel will not be allotted to the defaulter. There should not be any outstanding dues of the Institute against the tenderer.
28. In case of Tie of rates of diet per day, the allotment of the contract will be by Toss/Draw.

I have studied the above instruction carefully and I will abide by these terms & conditions.
